Chairman's opening remarks and Declarations of interest

Councillor Maxwell introduced Toni Bratby PCSO for East Team area which covers Burghwallis.

Speeding through the village was discussed at length as the Parish Council want to reduce the current speed of 30 to 20. Toni Bratby explained that serious or fatal accidents unfortunately have to occur before any action will be taken. Norton Parish Council reduced an area from 60 to 40. It was agreed to ask Councillor White to help and get any further information.

Toni Bratby reported she regularly attends the village with the hand held speed monitor, but is not allowed to issue any tickets unless the police are in attendance.

Cardinals Children's home was discussed with regard to ASBO's. The police attend the home regularly with reported incidents. Toni Bratby is aware of the problems.

Councillor Hudson reported on the motorbikes up and down the bridle path area. Bikes can be seized, and if too noisy can be destroyed.

Fires in bins on the bridle path was also reported.

Problems with contacting 101 in getting through was reported. This will hopefully be rectified in the coming months with more staff. Any problems the Parish Council can contact Toni Bratby for advice.
